Call to Order

The Commission Meeting was called to order at 2:08 P.M.

Consideration of the Minutes

MOTION: On a motion by Commissioner Calvet; seconded by Commissioner Mills and unanimously carried, the reading of the January 24, 2023 Commission Meeting minutes was waived and the minutes were approved.

Services Awards

LeMoyne Adams presented a 30-year service award to Dave Bramlett, Senior Engineer Distribution.

Jenise Osani presented a 20-year service award to Alandus Sims, Project Manager.

Community Recognition

Jenise Osani announced the 2023 OUC Charity Golf Tournament was held on February 25th. The Tournament has served to benefit non-profit organizations in the community for over 25 years, donating nearly \$1 million dollars benefiting 66 local non-profit agencies since its inaugural event in 1995. She shared a video highlighting the event and the charity beneficiaries and concluded by presenting donations of \$10,000 each to ten charities who make a difference in our community through economic development, education, environmental stewardship, and social impact. Mr. Adams presented on the 2023 FMEA Lineman Competition and FMEA Safety Award. He explained that the location where the lineman competition is hosted rotates between utilities. This year marked OUC's fourth time as the host utility. This year's Lineman Competition brought together more than 100 public power line workers from across the state to demonstrate their skill and knowledge in timed and judged events. It also promoted best practices and helped prepare municipal utilities for mutual aid situations. He announced that OUC brought home seven trophies in total in a variety of events. New Business

Jenise Osani and Mindy Brenay presented an update on the Robinson Recharge Mobility Hub and Level 3 Public Charging for Electric Vehicles – Pilot. Refer to the Appendix for more information.

Motion: On a motion by Commissioner Chapin and seconded by Mayor Dyer, New Business Item 1 was adopted and accepted as follows:

NB-1 Adoption of the proposed Level 3 Public Charging for Electric Vehicles - Pilot rate schedule effective May 1, 2023, pending Florida Public Service Commission review.

Presentation

Commissioner Mills provided the February 16, 2022 Audit-Finance Committee Report. The Audit-Finance Committee (Committee) meeting was held on February 16, 2023. The Committee was presented with revisions to the Audit-Finance Committee Charter for recommendation for Board approval. The Committee recommends Board approval of the Audit-Finance Committee Charter revisions. The Committee approved supporting Investment and Debt Charter Guideline changes that were presented for Committee approval, as well as a review of Energy Risk Management Charter Guidelines. The Committee also reviewed the electrification pricing update to support the opening of OUC's EV mobility hub. The Committee was provided with a financing update to support the 2023 Capital Plan, as well as needed funding for the projected five-year 2024–2028 Capital Plan. The





Committee approved a recommendation for the appointment of Mindy Brenay as ERMOC Chairperson. The Committee was also provided with an update on Hurricane Nicole's costs and the estimated FEMA cost reimbursement for recommendation for Board approval. The Committee recommends Board approval for the deferral of \$1.9 million of anticipated eligible FEMA cost reimbursement related to Hurricane Nicole. Quarterly financial updates were provided for the Energy Risk Management Committee, Internal Audit, and Financial Services. In addition, updates were provided on the Red Flag Committee and strategic sourcing process improvement activities.

Motion: Commissioner Calvet moved to adopt the revised Audit-Finance Committee Charter as recommended by the Audit-Finance Committee to re-define the Commission President's role as a voting member of the Audit-Finance Committee with the status to establish a quorum. Commissioner Chapin seconded, and the motion carried unanimously.

Motion: Commissioner Mills moved to defer \$1,875,000 of Hurricane Nicole emergency response and hurricane preparedness costs incurred in Fiscal Year 2023 as recommended by the Audit-Finance Committee consistent with the rate-making model and the Commission-approved Operating Budget. Commissioner Chapin seconded, and the motion carried unanimously.

Mindy Brenay presented the preliminary Financial Report. Refer to the Appendix for more information.

General Manager's Comments

Mr. Bullock provided a farewell message to Jan Aspuru, Chief Operating Officer (COO), who will retire on April 7th after 30 years of service. He stated that Mr. Aspuru began his career at OUC on February 1, 1993 as a Demand-Side Planning Engineer and highlighted his progression throughout his career. He became the first COO at OUC in 2018. Mr. Bullock continued by highlighting the numerous contributions in different areas such as design, development, collaborations, community relations, and leadership. He concluded by thanking Mr. Aspuru for his years of service and his impact to OUC.

Commissioners' Comments

Commissioner Calvet thanked Dave Bramlett and Alandus Sims for their years of service at OUC. He described meeting Jan Aspuru in 1993, and he thanked him for a job well done as well as for his service.

Commissioner Mills expressed appreciation for the DE&I dialogue during the Conversation With a Purpose presentation. He encouraged the expansion of this concept to other parts of the commission, and continuing an open dialogue throughout the community. He further stated that he looks forward to the Robinson Recharge Mobility Hub project, and is always excited to see the service awards and community recognitions. He expressed gratitude to Jan Aspuru for his contributions as COO.

Commissioner Chapin expressed his appreciation to everyone who assisted in answering his questions in his new role as Commissioner. He expressed appreciation for an uplifting meeting, stating he loved seeing the Linemen Competition and the community work OUC does.

Mayor Dyer is glad the meeting highlighted DE&I efforts in the current political climate. He announced all events in the City which will be held for Women's Month, details can be found at Orlando.gov. He spotlighted the Women's Suffrage Plight event held at the historic Angebilt Hotel. He stated this event will bring to remembrance a woman who earned the right to vote a year before the 19th Amendment was passed in Orlando and mentioned Orlando has always been a leader in equity and inclusion. He

President Gross encouraged everyone to attend a Lineman Competition event, stating the skill, dexterity, safety, and camaraderie were amazing to watch. 



Robinson Recharge Mobility Hub

- In May 2023, OUC will energize its first highspeed recharge Mobility Hub with Level 3 chargers on Robinson Street
 - Universal Chargers All makes and models can charge
 - Chargers Manufactured by Power Electronics
 - Three dual-port; 240kw dispensers; Six total charging spaces
 - 14 single-port; 120kw dispensers;
 14 total charging spaces
 - Charging Network is provided by NovaCharge










Level 3 Public Charging for EV's - Pilot

- Recommend pilot billing price of 35¢ / kWh plus an idling fee of \$1.00 per minute after 10 minute grace period
 - Encourages vehicle turnover after full charge
- · Billing design is consistent with peer utilities in Florida
- Pilot structure will be reviewed over the next 12 18 months
- Pilot display meter, billing, and collection services provided by NovaCharge Inc. through the "ChargeUP" network

A 300 mile range EV can charge from 20% to 80% for approximately \$10 in about 30 minutes on the 120kw charger and in about 15 minutes on the 240 kw charger.

These times will vary based on car manufacturers and battery limitations because they are not standardized

Overview

- Total Revenues, excluding Fuel Revenues were \$0.4 million lower than Budget.
 - Unexpected wholesale revenues of \$7.9 million substantially offset the impact of the retail electric base price reduction approved by the Board in October 2022
 - Deferred revenues of \$25.0 million continue to be available to mitigate potential prospective electric retail base revenue shortfalls
