Thom Nealson provided a recap of the OUC Commercial Fleet Ride & Drive Event, which was held on November 7th- 9th at the SunTrax, the Florida Department of Transportation's Autonomous Vehicle test track in Auburndale, FL. Commissioner Chapin asked if the event would take place annually, and Mr. Nealson responded that frequency is still being determined. President Gross also inquired if any fleets had accepted OUC's offer to do a fleet analysis. Mr. Nealson explained that three fleets accepted the offer for OUC to conduct a fleet analysis. Mr. Bullock recognized and congratulated Jan Aspuru, OUC's former Chief Operating Officer, for receiving the Hispanic Community Lifetime Achievement Award at the Don Quijote Awards ceremony hosted by the Hispanic Chamber of Commerce of Metro Orlando and Prospera on December 9th.

Commissioner Chapin thanked everyone for the birthday wishes and recognized Commissioner Calvet for his many years of service and leadership in the community.

Commissioner Mills acknowledged that he is always enthusiastic about OUC's community outreach. He expressed admiration for the level of participation during the OUC half marathon and commended OUC on the customer transaction surveys. He also recognized Commissioner Calvet, wishing him a farewell.

Commissioner Cesar Calvet

Whereas, the Orlando Utilities Commission (OUC) wishes to express our heartfelt appreciation to Cesar Calvet for his leadership and support while serving on OUC's Governing Board as a Commissioner and President. Mr. Calvet joined OUC's Board in 2016 and was unanimously elected president in January 2019. After completing his two-year presidential term ending December 2020, Mr. Calvet remained on the Board as a Commissioner, the position he will leave on December 31, 2023. He will be deeply missed.

Whereas, while Mr. Calvet served as President of the Board, he supported a series of transformational initiatives at OUC, most notably our Connected 2025 Strategic Plan, which established our Mission, Vision and Values, and pledged net zero CO₂ emissions by 2050 with interim goals of 50% by 2030 and 75% by 2040. Additionally, he championed OUC's Electric Integrated Resource Plan, a commitment to build a more sustainable energy grid by closing the Unit 1 coal plant by 2025, converting the Unit 2 coal plant to natural gas by 2027, made possible with the purchase of the Osceola Generating Station to mitigate solar production fluctuations.

Whereas, Mr. Calvet's stewardship as president supported OUC's expansion of utility-scale solar power with the opening of the Taylor Creek and Harmony Solar Energy Centers; our groundbreaking 20-year service agreement with the Greater Orlando Aviation Authority which includes service for chilled water, back-up generation and floating solar; the launch of several vehicle electrification initiatives, among them our partnership in LYNX's e-bus program, installation of EV charging dispensers across the city, and our announcement to build the Robinson Mobility ReCharge Hub in downtown Orlando.

Whereas, his steady leadership helped guide OUC through formidable challenges brought on by the COVID-19 pandemic in 2020, with OUC responding to the crisis with a Board-approved \$12.1 million aid package that lowered fuel rates; offered utility bill payment assistance to financially distressed residential and small business customers; and steered the organization through water reduction to ensure liquid oxygen, used in water purification, was redirected for COVID medical treatments of critically ill patients in local hospitals.

Whereas, during Mr. Calvet's presidency, OUC was named the 2020 "Most Trusted Brand" among U.S. electric utilities, setting the stage for us to reclaim the honor in 2022 and 2023. His reign also marked navigating rising fuel costs while strengthening in OUC's financial health and higher bond ratings, and the beginning of our efforts to support diversity, equity and inclusion practices in the interest of fostering a more inclusive working environment.

whereas, as an immigrant from Cuba, Mr. Calvet sought to make a positive impact in his new homeland by serving in the U.S. Marine Corps and earning a college degree in business administration. While building a successful career as a bank executive in Central Florida, he also found time to give back to the community through public service, with stints as Chairman of the Greater Orlando Aviation Authority and President of the Hispanic Chamber of Commerce. Additionally, he served on numerous boards, including the Orlando-Orange County Convention and Visitors Bureau, the Economic Development Commission of Metro Orlando, and the Florida Housing Finance Corporation.

Now, Therefore, Be it Resolved, Mr. Calvet's service to OUC's Board as a Commissioner and President, as well as to the Central Florida community and our country, has made a positive and lasting difference.

Be It Further Resolved, the Orlando Utilities Commission is beholden to Cesar Calvet for his leadership, loyalty and friendship and extends our best wishes to him.


